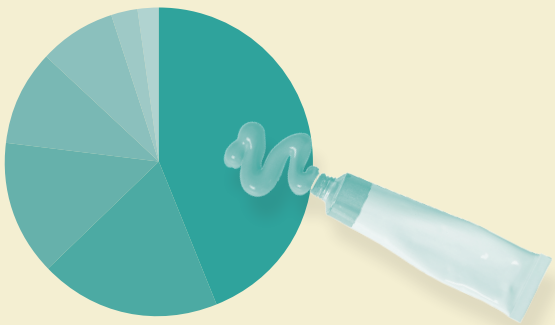

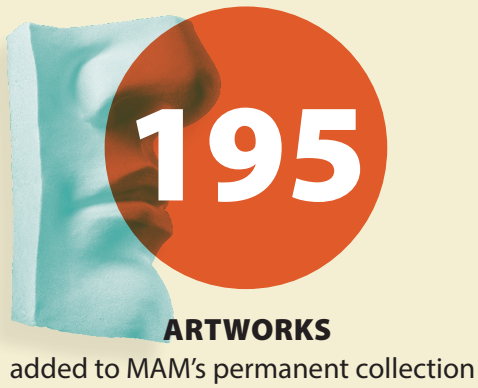
COMMITMENT TO ARTS EDUCATION
